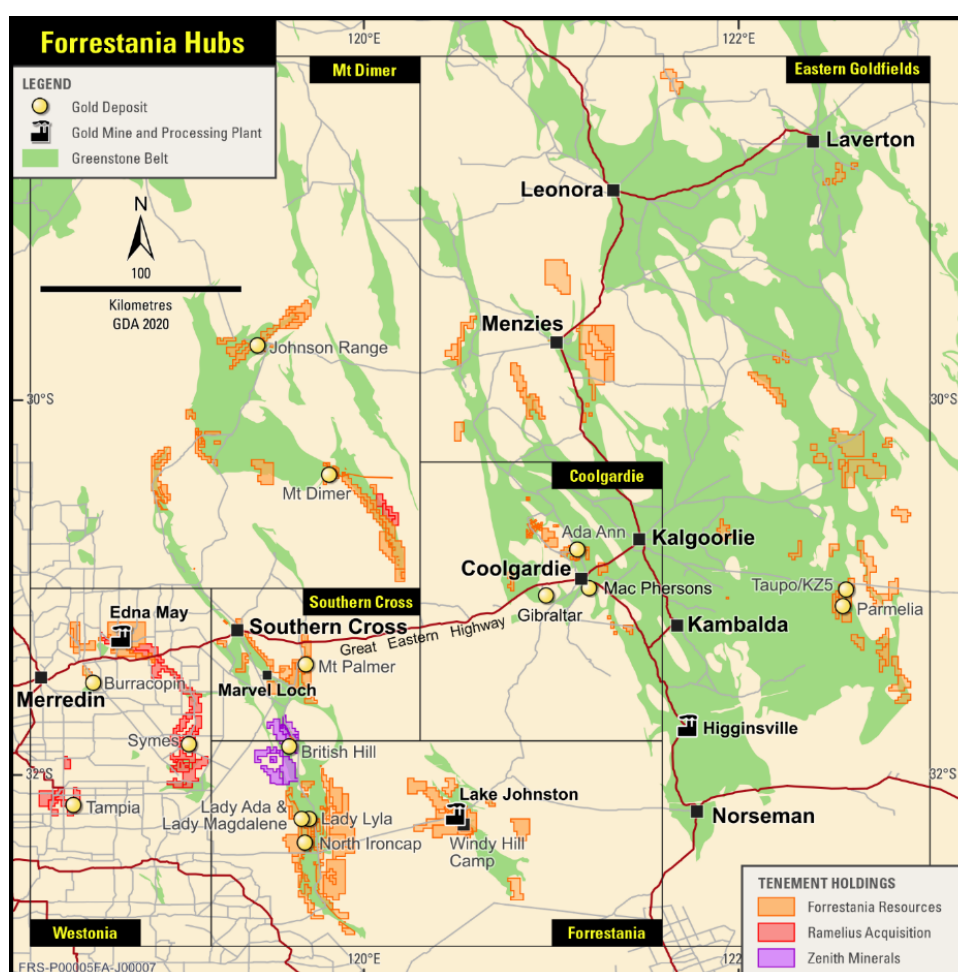


Figure 1. Forrestania Regional Location Map
